West Bengal Medical Services Corporation Limited (WBMSCL) intends for Supply, Installation, Testing & Commissioning (SITC) of Medical Oxygen tanks having desired storage capacity of 45 ton x 10 nos. of liquid oxygen at 10 Hospitals of West Bengal, as per specification enclosed. In this regard, WBMSCL invites eligible manufacturer/ their authorized distributor/ any other vendor/agency to submit 'Expressions of Interest' in participating in the subsequent tender exercise for the work of SITC of Medical Oxygen tanks having desired storage capacity of 45 ton x 1 nos. of liquid oxygen each at 10 Hospitals of West Bengal as per specification enclosed for treatment of COVID-19 patients in this pandemic.

### a) Background:-

The objective of the EOI is immediate enhancement of the treatment facilities of West Bengal for COVID-19 critical patients by carrying out the SITC of Medical Oxygen tanks having desired storage capacity of 45 ton x 1 no. of liquid oxygen each at 10 Hospitals of West Bengal, as only COVID-19 positive patients are being looked after in the hospitals.

# WHO CAN SUBMIT EOI:

- A. Applicant shall be manufacturer or their authorized distributor /dealer of Liquid Medical Oxygen Tanks.
- B. Manufacturer or authorized distributor/dealer should have satisfactorily executed the work of supply of 40 Ton capacity liquid oxygen/medical gases storage tank in Semi Govt./ Govt. & Public/private Sector Organizations during last seven (7) years ending last day of month previous to the one in which EOI is invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this document.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

### Scope of Work:

The scope of this work will be as bellows:

- Supply, Installation, Testing and commissioning of new 45 tone x 1 no. capacity liquid oxygen tank each at 10 hospitals of West Bengal.
- Supply, Installation, Testing and commissioning of allied equipments such as vaporizes, skid, VIE panel etc.
- Carrying out necessary civil work such as foundation, fencing, water connection etc.required for commissioning of liquid oxygen tank.
- Carrying out necessary electrical works such as area lighting, earthing, connection to VIE panel etc. required for commissioning of liquid oxygen tank
- 5) Providing safety gears such as fire extinguishers, sand buckets, safety signage etc.
- 6) Obtaining all the necessary PESO approval and license for commissioning and uses as well as refilling of D-type cylinders and other cylinders from this tank.
- 7) Comprehensive Service and Maintenance Contract of the installed system which will cover spares, consumables, man power and tools and tackles, etc. for a period of 5 years.
- 8) Skilled staffs for day to day operation and visiting sites and trained labours are required as per requirement.
- 9) For Periodical maintenance and smooth operation it is required to change spare and parts as and when require.
- 10) Insurance must be covered up including third party insurance.

Over and above this, the tenderer shall also include all the associated minor works like electrical wiring, plumbing, masonry/carpentry works, required for successful completion of work. The contractor may include any other work not specifically stated above but which they think is necessary for efficient working of thesystem or not included in the bill of quantities. The quantities specified in the estimateare based on the proposed design.

- All dismantled materials shall be kept in the premises of the hospital.
- 2. The damages if any caused to the hospital properties shall be recovered from the successful contractors at their risk & cost.
- The works shall be carried out through out 24 hours.
- WBMSCL/ Hospital authorities will not be responsible for any accident/ hazard caused to the person of the contractors while carrying out works.
- The electric power & water supply required for carrying out works shall be made available by the hospital authorities, wherever available. However, the contractor shall arrange to tap the supply from the service available at site pointed out by the Site Engineer.
- All the material to be used shall be new and from the fresh stock.
- 7. The successful contractor shall give the satisfactory testing of the liquid oxygen tank.
- Any minor work not specified in the scope/BOQ/schedule, but required for satisfactory/successful commissioning of entire work, shall deem to consider in the scope of work.




# **Important Conditions:**

1) Delivery Period: The quantities in BOQ are indicative and not exhaustive and may change as per requirement. Separate work order/s may be placed as per the requirement. After issue of work order, work shall be completed within Six weeks considering COVID-19 Pandemic.

# 2) Payment Conditions:-

Since the time period of the project is Six weeks along with 5 years of CSMCperiod after one year DLP, it is proposed to make payment in stage wise manner as mentioned below-

As per procedure the payment of work done will be made within 30 days from the receipt of bill subject to verification as per normal rules. However 3% amount of entire contract value, towards security deposit will be deducted from the bill. The security deposit will be released after completion of defect liability period.

### 3) Penalty Terms:-

Penalty for delayed execution (beyond original contract period) shall be calculated at the rate of 1% percentage per week or part thereof of the contract value of partdelayed subject to max. limit of 10% of contract value.

Before quoting the rates, bidders shall inspect the site, system installations. No extra claim whatsoever will be entertained later on during the contract period.
