- 2. The rates quoted shall include all applicable taxes.
- 3. Regular servicing & inspection of the equipments should be carried out at least once in a month preferably during 1^{st} week of the month by the service provider.
- 4. The service provider shall perform preventive maintenance to the equipments mentioned above and its accessories as per service manual provided by the WBFES.
- 5. The service provider shall also attend any breakdown & emergency call immediately.
- 6. An agreement detailing the terms & conditions shall be executed with the service provider for entering into a AMC.
- 7. The service provider shall furnish details of experience indicating the parties for whom similar assignments AMC were undertaken.
- 8. The bidder will quote unit rate for various items of fire fighting system. This rate will be valid for 360 days from the date of work order.

The AMC will be for a period of Three (03) Year, which is extendable for further if required depending on satisfactory fulfilment of all "Terms Conditions' of contract agreement. ANNEXURE – III

SPECIAL CONDITIONS OF CONTRACT

Scope of work and maintenance schedule:

- 1. Maintenance of Fire Fighting, Fire Alarm & Fire Detection system in the areas under this contract the maintenance agency (contractor / firm) shall be solely responsible to keep the system serviceable at all the time. The maintenance shall include servicing of all the equipments associated with the systems.
- 2. The cost of major or special repair or overhauling of any equipment such as Fire pump, motor, fire alarm panel, batteries & hooters including winding of motor is not covered in the scope of this work. However, preventive & routine maintenance including servicing, minor rectification will be the responsibility of the agency. All material including diesel oil for fire engine pump will be provided to the agency by WBMSCL for such rectification free of cost except some minor material such as Petroleum Jelly, straw, lubricants, tools & tackles, nuts & bolts, distilled cleaning water, materials (soda packing, & waste cloths etc.), log books & Stationeries, fuse, rubber indicator lamps, clamps, resistors, diodes, repairing of Integrated circuit (IC / PCB) etc. which are in the scope of this work. Nothing extra shall be paid on account of consumables and small tools & plants required for the work.
- 3. The agency will promptly inform WBMSCL engineer in charge as soon as occurrence of any Major defect in these systems is noticed. So that the latter can take advance action towards its rectification and procurement of any material required for that purpose. Labour for the rectification will be provided by the agency in his quoted rates.
- 4. The Firm/ contractor will engage trained and experienced technical staff and helpers, headed by a qualified Fire supervisor, for undertaking maintenance services / jobs.
- 5. The firm / Contractor will maintain the logbook for maintenance as described below.
- a) After each maintenance, the test details to be entered in the maintenance register with dates and result achieved.
- b) After carrying out each test, the entry in the register to be got counter signed from the WBMSCL Engineer. Without prior approval, no fitting / material will

be removed for repairs; it will be contractor's responsibility to provide alternative temporary arrangement of such items during the period, the item is repaired and put back in to position so that the system remains fully functional all the time.

- 6. The contractor will conduct periodical (quarterly or as and when asked by the employer) fire drill at site as per direction of the engineer in charge including imparting training to the staff in the use of fire Extinguishers etc.
- 7. The checking & maintenance of the batteries for the system shall be done including maintaining specific gravity and distilled water if required. However replacement of defective batteries is not covered in the scope of this work.
- 8. The servicing & random checking of fire detection system & heat detectors shall be done periodically.
- 9. The system shall be kept in working condition till completion of the contract. The firm will arrange handing over of the total system in full functional condition on completion of the contract.
- 10. The mock drill/demonstration of the working of the system shall be given at least once in a month or as and when desired by the engineer in charge or as per his direction.
- 11. The firm / contractor shall depute one qualified Electrical Engineer to check the whole system once in every alternate month and shall maintain a test record signed by him and got countersigned from the Engineer of the WBMSCL. The firm shall guide the operator engaged by the WBMSCL about the operation of each of the equipment.
- 12. In case of Emergency, The Firm shall give full support for mitigation of fire accident at no extra payment.
- 13. The firm has to arrange for testing both the fire pumps. The test includes running of the pressurization pumping set in case of loss of pressure of fire hydrant system and running of diesel engine pump by artificial closure of electricity. The pumps shall be tested as to whether the constant pressure is being maintained by creating pressure loss in the pipe lines. Pressure test at the various locations of hydrant valves shall be done by

opening the valve at one location. Such test shall be done at least once in every alternate month in the presence of Engineer in charge of WBMSCL.

- 14. The servicing of major equipments like fire pump, jockey pump, pressure regulator & main fire alarm panel etc. shall be done quarterly. However, all the valves, valve handles, smoke detectors, manual call points, hooters, fire control cable etc. shall be checked and greased if required in every month.
- 15. Contractor would be bound to execute such additional item/ items which may be essential & necessary (even though not listed in schedule of work) for the effective execution of the work. Rates for such extra items of work shall be rationally analyzed / derived & would by binding on the contractor.
- 16. Contractor undertaking the job is advised to verify the particulars as detailed in annexure & satisfy himself towards the conditions & specifications etc. of the tenders before filling up the bids.
- 17. Penalty: The firm shall rectify/attend any breakdown within 48 hours failing which penalty for non-performance @ Rs. 500/- per day of delay subject to a maximum of 10% of the contract price of the respective site will be imposed and in the event of any damage to the property or life arising out of non performance, contractor will be solely responsible.
- 18. The contractor should provide escalation matrix to WBMSCL to lodge complaint of breakdown. In the escalation matrix the contractor has to provide at least 02 mobile no. and email ID. If any changes is made in mobile no. / e-mail ID the same should be notified to WBMSCL in written within 7 working days.

ANNEXURE - IV

Maintenance Schedule

The following works / checks are required to be performed on Monthly / Quarterly / Half yearly basis and record all the activities in the log book with date and time which shall be counter signed by the Engineer – in -Charge / competent authority of WBMSCL.

1. Monthly checks:

- a) Operational readiness of system during mains failure
- b) Check battery water level & Specific Gravity of electrolyte
- c) Check the fire circuit of each zone from the panels
- d) Check whether signals of fire and fault get transmitted from zonal panel to main panel.
- e) Performance check of the hooters shall be done along with the performance check of manual call points.
- f) Check smoke detectors, if required cleaning shall be carried out with suitable reagents.
- g) Checking of water pressure of the hydrant line & action shall be taken to arrest leakage on urgent basis.
- h) Checking of main control panel of fire pump & alarming system

2. Quarterly checks:

- a) Check fault circuit of each zone by actually disconnecting wire by removing a detector.
- b) Check fire circuits by facilitating actual smoke to one detector of each zone
- c) Cleaning of all types of detectors with suitable means.
- d) Checking / servicing of major equipments such as Fire pump, Jockey pump, pressure gauges, panels including contactors, valves, main alarm panel, auxiliary panel etc.
- e) Checking/testing of all type of fire extinguishers

3. Half yearly checks:

- a) All the checks quarterly's shall be repeated
- b) Greasing of valves, checking of couplings / Impeller and checking of synchronization operation of Main pump, Jockey pump & Diesel pump during mains failure.
- c) Oil filtration of Diesel Engine Pump
