- 2. Eligibility Criterion for participation in the tender/ Quotation.
 - i) Intending bidders should produce credentials of o1 (one) similar nature of works i.e. any type of supply work during the last 5 (five) years viz. 31st May 2014. The value of work should be minimum Rs. 12,00,000/- (Rupees ten lakh only) for single work or two supply work totalling Rs. 12,00,000/- from which the minimum value of one work shall be Rs. 8,00,000/-.

- 3. The contractor can search & download NIQ & Tender Documents electronically from computer once he logs on to the website mentioned in Clause 2 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

AWARD OF CONTRACT
