The Technical bid consist in of all technical details along with commercial terms and conditions while financial bid will contain % of discount to be allowed on overall total amount of printed of all journals in Indian currency only and should be sealed in separate cover duly super scribed and both the sealed cover are to be put in a bigger cover, with also should be sealed and super scribed. The documents submitted as quotation paper must be typed on company or agency's own letter head and out cover with superscription on the top to the cover quotation for Journals for Jalpaiguri Govt. Medical College & Hospital, Jalpaiguri, for the year 2022-2023. Edition and year of publication of Journal must be latest and it must be noted in the quotation.

Intending Quotationer must have minimum Rs. 40000/- (Rupees 40 thousand only) for supply record to leading academic education/ research and ICAR institute, Central Universities and Other UGC recognized University, Health University and Medical Colleges carried out within last 3 years from the date of publication of this NIQ.

Quotation will be opened on 19.07.2022 at 4 pm at the conference hall of WBMSCL, HQ at Swasthya Sathi Building, 2<sup>nd</sup> floor, Swasthya Bhawan Complex, GN-29, Sector-V, Kolkata-700091 in presence of quotationers or their authorized representative (one for each agency). **Earnest Money** amounting Rs. 2,000/- (two thousand only) payable to West Bengal Medical Services Corporation Limited in the form of Bank Draft is to be submitted along with the other documents as stated below:

**The Technical Bid** must accompany the following documents:-

1. Self-attested copy of certificate of valid membership of any recognized Publishers/authorized Agent/vendor.
2. Self –attested Copy of verified Income Tax Return (Last Three years- 2019-20, 2020-21, 2021-22)

3. Self-Attested Copy of Average Turn Over duly certified by CA/Cost Firm (Last Three years-2019-20, 2020-21, 2021-22)
4. Self-attested copy of valid PAN Card.
5. Self-attested copy of valid Certificate of Enlistment (Trade License)(current year).
6. GST Registration Certificate (if applicable).
7. Credential Certificate of supplying Journals in reputed institutions.
8. The quotationer should submit a self declaration that supply all the journals (as per list enclosed with the quotation) and latest edition of the Journal will be supplied.
9. EMD amount to be mentioned clearly.

**The Financial Bid** will contain % of discount to be allowed on overall total amount of printed price of all journals and total discount amount in Indian Currency only.

**General Terms of conditions:**

1. Rate of discount should be quoted against the printed price or catalogue price of the Medical Journals.
2. Rate must be quoted all copies in one year in INR (Rupees) only for the latest edition of each Medical Journals.
3. The quotationers should quote for all original copies of Medical Journals.
4. Rate of all copies of each Medical Journal should be quoted inclusive of all taxes, incidental charges and free delivery to the office of respective principal of Medical Colleges.
5. Orders of the estimated requirements will be placed to the successful quotationers and supplies thereof will have to be made within the date as specified in the order otherwise the order will be treated as cancelled.
6. Rates must hold good throughout the years or for such extended time as the Tendering Authority. If there will be any change in printed price of any medical Journal, the increased price may be considered in subsequent years, subject to submission of application along with proper proof of price from the publisher. After verification of documents, a corrigendum order may be issued in this regard. However, the rate of discount must be constant and other terms & conditions of the NIQ will remain the same as quoted by the bidder (L1) in case of future extension. There will be no change of quoted price in current year.
7. Quotation should be submitted in sealed cover and superscribed with the name of the work quoted for with NIQ No.
8. The rates are to be quoted both in words and figures as per schedule and perusing necessary Terms & Conditions attached herewith. The rate quoted is valid for acceptance upto 6(six) months from the date of opening of the Quotation. The rates quoted should be considered as inclusive of sales tax and other taxes and all other charges. No claim for any extra charge what so ever will be entertained.
9. The quotationer should sign all corrections in the quotation with the date. The Quotationer must sign each page of the quotation paper, notice, relevant documents, schedules etc. which forms part and parcel of the quotation document. The intending quotationer is required to sign in English or Bengali or Hindi. Signature of quotationer in all locations must be identical but the rates shall be quoted in English only.
10. Rate must be valid for one year for the finalization of the Tender.

11. Quotationer who will sign on the Quotation on behalf of a company or firm must produce the registered documents in respect of their competency to do so, failing which the Quotation will not be considered.
12. Income tax and VAT will be deducted as per Govt. orders issued from time to time and would be applicable on the date of making payment of the bills.
13. Quotation will be opened in presence of quotationers or their authorized representatives who may be present at the time of opening if they may desire so.
14. The acceptance of the Quotation will rest with the accepting authority who does not bind himself to accept the lowest or any quotation and reserves the right to reject any or all the Quotations received.
15. In case of sudden closure of office due to reasons beyond the control of the undersigned, the last date and time as indicated above will automatically be deferred to the next working day without further notice.
16. Letter or other instrument submitted separately in modification of the sealed quotation will not be entertained.
17. Canvassing in any form is strictly prohibited and any quotationer found to have resorted to canvassing shall be liable to have his Quotation rejected summarily.
18. Journals should be supplied within **one month** from the date of placement of order or date of publication of the selected journal, failing which orders are liable to be cancelled and EMD will be forfeited.
