# 1.SPECIAL TERMS AND CONDITIONS FOR INFRARED MEDICAL THERMOMETER FOR MEASURING BODY TEMPERATURE

1) The seller/supplier shall fulfil/compy all the requirements under the Legal Metrology Act, 2009 and Rules made there under.

2) The importer of Infrared Thermometer shall be registered under section 19 of Legal Metrology Act, 2009 and Rules made there under.

3) Model shall be approved under Section 22 of Legal Metrology Act, 2009 and Rules made there under.

4) Manufacturer or Seller of Infrared Thermometer shall have valid license issued by the Controller under Section 23 of Legal Metrology Act, 2009 and Rules made there under.

5) Dealer shall hold valid dealership license under the provisions of Legal Metrology Act, 2009 and Rules made there under.

6) Manufacturer, Packer and Importer shall be registered under the provisions of Rule 27 of Legal Metrology (Packaged Commodities) Rules, 2011 as amended till date.

7) Declarations shall be made on every package in accordance with Rule 6 of Legal Metrology (Packaged Commodities) Rules, 2011 as amended till date.
